The Woodworking at IU group has an agreement to allow its IU student members to use our woodshop. Part of this agreement is that at least one of their members maintains an active Bloominglabs membership so that this member may facilitate access for the rest of their group.

This group meets twice weekly at Bloominglabs (approximately 100 meetups per year).

Cub Scout Pack 100 utilized the Bloominglabs space, equipment, and volunteer expertise to host their Pinewood Derby Build Day.

Narrative and Summary For Year 2023

We signed a new 3 year lease with modest fixed rate increases each year (less than current inflation). We avoided any deviations in the lease wording that were not to our liking.

We seem set on keeping the same member size or growing.

Ingress water issue is not fully resolved, but it seems most of our items have escaped damage. The landlord does not seem willing to intervene.

The non-paying members have been dealt with.

Republic trash services has been removed as a contractor of ours and we have permanently switched to Ava's for the foreseeable future.

Comcast rate has been renegotiated, also saving us a considerable amount of money each year.

0 official fires reported.

We did not host any sizable workshops as a means to draw in new members this year.

Makevention was hosted successfully at its new location, Switchyard Park, with equal or greater attendance compared to 2023. The Makevention Committee is further experimenting with the event's timing, and plans to run the next Makevention **October 12, 2024**.

The Impound Lot has seen some results in redirecting abandoned projects/materials out of the space, though room for improvement remains.

The Digital Fabrication Lab acquired two new functional 3D printers, divested itself of two old devices, and was generally re-organized.

The Craft Room has been re-colonized for use as the meeting/greeting space during Public Nights.

A new sign to advertise Bloominglabs has been built, installation pending.
